Eric Kuwana has been recognized as one of the nation's top trial lawyers by the *National Law Journal* and represents companies in significant disputes across the country, advises senior management and board committees, and brings broad experience across government, private sector industries, and a wide range of lawsuits to solve his clients' most pressing problems. Eric regularly represented political campaigns and committees, and also served as Deputy General Counsel for the inaugurations of President George W. Bush.

Before joining Alston & Bird, Eric held leadership positions in two national law firms for their national litigation and securities litigation practices and as a member of their boards of directors.

### *Representative Experience*

#### **Commercial & Civil Litigation**

- Lead counsel for an international insurance brokerage in disputes, arbitrations, and court actions following an M&A transaction with a large UK based insurance brokerage, which resulted in a global settlement.
- Lead defense and trial counsel for a REIT defendant in a complex federal court lawsuit filed by a national publicly traded homebuilder in a real estate and real estate finance dispute alleging environmental, breach of contract, and other claims in highly contentious litigation spanning eight years. Implementing an aggressive defense and launching counterclaims, the defendant achieved the rare complete trial victory as a defendant: it defended all claims brought against it and won on its counterclaims. After a multiweek trial, the court found that the plaintiff acted in bad faith trying to avoid its contractual obligations and entered judgment in favor of the defendant and against the plaintiff exceeding \$235 million and then later also judgment for an additional recovery of attorneys' fees and costs. The judgment was affirmed by the Fourth Circuit, and the U.S. Supreme Court denied the plaintiff's petition for certiorari. (D. Md.).

- Lead counsel for the majority shareholder in a new economy company relating to a complex dispute and arbitration with the minority owners and founders of the company.
- Lead counsel for a new economy technology company relating to a complex commercial dispute and arbitration with a Bitcoin miner equipment company.

## ***Products Liability & Catastrophic Injury Litigation***

- Lead trial and national coordinating counsel for four defendants – a national warehouse retailer, a manufacturer, and two supply-chain companies – in products liability cases in federal and state courts across 10 western states arising out of a large food borne outbreak and recall of an organic frozen berry blend. Plaintiffs’ counsel brought hundreds of individual cases and a consolidated class action with eight-figure exposure and many multiples of that in punitive damages. In the first bellwether trial, a lengthy products liability and wrongful death trial in Los Angeles Superior Court with punitive damages, the jury delivered a unanimous defense verdict in the defendants’ favor.
- Lead defense and trial counsel representing a tire company in a products liability and catastrophic tort lawsuit in state court involving an SUV rollover, quadriplegic injuries, a three-month trial, and a nine-figure exposure. The trial resulted in a hung jury, and an innovative settlement was negotiated while the jury deliberated, protecting the client from a second trial. (Orange County, CA).
- Lead trial counsel defending a publicly traded company at trial in a wrongful death action in state court arising from the death of a senior executive of a competitor. Obtained a defense verdict at the third and final trial of the matter after an eight-figure jury demand by a nationally known Florida plaintiff lawyer. (St. Petersburg, FL).
- Coordinating defense counsel in multiple wrongful death actions brought in state and federal courts against a publicly traded company arising out of an incident at a Louisiana manufacturing facility.
