- Representing a multinational energy company regarding CEQA compliance for the transformation of a refinery to the largest renewable fuels facility in the world, including consideration of land use, environmental permitting, and related litigation for the project. Facilitated project approvals and successfully defended the project in trial court, allowing project operations to proceed. Also advising the company regarding CEQA compliance for other California facilities.
